Dear Judge and Commissioners:

In accordance with Local Government Code Section 111.093, a requisition issued or a contract for work, labor, services, or materials and supplies is not binding until the county auditor certifies that the budget contains an ample provision for the obligation and that funds are or will be available to pay the obligation when due. Recommend that agreements/contracts be revised to include the County Auditor's signature as certification of available funds.

Regular Agenda Item 14.B. (AI-54703) – Urban County
Recommend No Action: The term of the contract extends beyond Commissioner Precinct 1's term. Also, we requested an opinion from GLO regarding a possible conflict of interest that would require a waiver from GLO and are awaiting their response.


Regular Agenda Item 17.A. (AI-54764) – Precinct No. 2
Recommend No Action: The Resolution was not attached.

Regular Agenda Item 20.B.1 (AI-54399) – Drainage District No. 1
Recommend No Action: This agenda item was erroneously placed on the County's agenda instead of the Drainage District's agenda.

Regular Agenda Item 20.B.2 (AI-54647) – Purchasing Department for Precinct No. 1
Recommend No Action: The two work authorizations will be funded with FEMA Disaster Recovery grant funds. If approved, these two work authorizations for 3 (of 12) sites will use up approximately 85% of the engineering funds allocated for all 12 sites. There may not be enough funds for engineering available for the remaining 9 sites.

Regular Agenda Item 20.C.1 (AI-54733) – Purchasing Department for Precinct No. 2
Recommend No Action: The Certificate of Interested Parties (FORM 1295) was not attached. Therefore, we could not determine compliance with Section 2252.908 of the Government Code.
