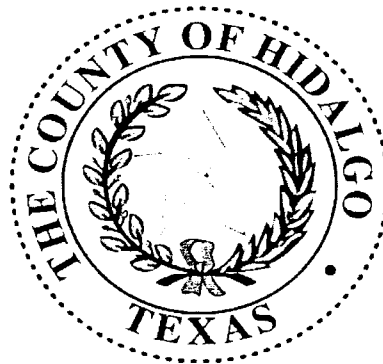

Dear Judge and Commissioners:

In accordance with Local Government Code Section 111.093, a requisition issued or a contract for work, labor, services, or materials and supplies is not binding until the county auditor certifies that the budget contains an ample provision for the obligation and that funds are or will be available to pay the obligation when due. Recommend that agreements/contracts be revised to include the County Auditor's signature as certification of available funds.

Consent Agenda Item 12.P. (AI-54965) – Purchasing Department

Recommend No Action for SBA Towers IV, LLC: The Certificate of Interested Parties (FORM 1295) was not attached. Therefore, we could not determine compliance with Section 2252.908 of the Government Code.

Regular Agenda Item 7.C. (AI-55141) – Executive Office

Recommend No Action for CR-15-06593-A (\$400), CR15-11082-E (\$735), and CR-2690-15-A (\$1,105): On February 9, 2015, the Board of Judges amended the Local Rules on Indigent Defense. Rule 8.01 of the Local Rules stipulates that "no claim will be paid unless properly submitted within 45 days of disposition." The above listed invoices were not submitted in compliance with Rule 8.01. Attorney Sidney R. Meadows signed a contract on May 21, 2015 acknowledging and agreeing to abide by the Local Rules.

Recommend No Action: Pursuant to the Fiscal Note attached, funding for this item is undetermined.
