**AMENDMENT#1  
TO MEMORANDUM OF AGREEMENT BETWEEN HIDALGO COUNTY AND THE  
UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT HOUSTON-  
BROWNSVILLE CAMPUS**

This AMENDMENT to the Memorandum of Agreement, between University of Texas Health Science Center at Houston by and through its School of Public Health, (the Regional Academic Health Center in the Lower Rio Grande Valley) hereinafter referred to ("the SPH-B") and **HIDALGO COUNTY, TEXAS** ("COUNTY"), effective 27<sup>th</sup> day of September, 2016, is made between the SPH-B and the County, (the "Amendment"), as follows:

**WHEREAS**, SPH-B and County executed the Memorandum of Agreement, between SPH-B and the County on June 2, 2015, in which the County agreed to provide Use of Office Space and for cooperative efforts between both institutions in the field of chronic care and diabetes management. (the "Agreement");

**WHEREAS**, due to the continuation of the program the parties desire to extend the timeframe of the agreement under Paragraph II. TERM OF AGREEMENT; and

**WHEREAS**, the parties desire to amend the Agreement as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and SPH-B hereby agree to the following amendment to the Contract.

1. Paragraph II. Term of Agreement, is hereby deleted in its entirety and the following sentence substituted in lieu thereof:

The term of this Agreement will begin on the June 23, 2015 and end on December 31, 2017.

2. Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect and SPH-B and County ratify and confirm the terms and provisions of the Agreement, as amended by this Amendment.
