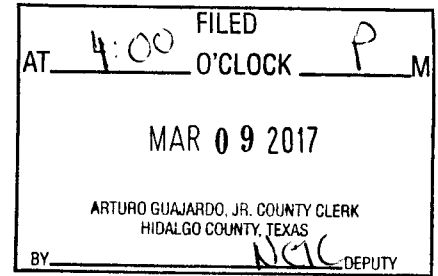

**AMENDMENT TO  
CONTRACT #C-14-016-05-20**

This **AMENDMENT** to the **CONTRACT** is made this 24<sup>TH</sup> day of **JANUARY of 2017** by and between **HIDALGO COUNTY, TEXAS** (the "COUNTY") and **UniFirst Holdings, Inc** (the "Seller"). **WHEREAS**, COUNTY and SELLER entered into a Contract on December 20, 2014 (the "CONTRACT"), which was extended for an additional one year term that expires on June 29, 2017, in which the SELLER agreed to provide services for the scheduled delivery of clean non-slip mats, dust mops, shop rags and other janitorial items to the listed Hidalgo County Departments, as well as other services as described in the CONTRACT; and

**WHEREAS**, the COUNTY due to certain circumstances now requires further clarification of the services to be provided by the SELLER and hereby requires the amendment of the Contract; and

**WHEREAS**, the COUNTY desires the SELLER to provide the services as described in the **Specifications/Requirements**, attached as **Exhibit "A"**, to the Hidalgo County Forensic Center located at 3100-A South Business 281, Edinburg, Texas 78539; and

**WHEREAS**, the COUNTY and SELLER now desire to amend the **CONTRACT** as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, COUNTY and SELLER hereby agree to the following amendment to the **CONTRACT**

1. Attachment "I" - Location Sites, shall be amended herein to include the Hidalgo County Forensic Center located at 3100-A South Business 281, Edinburg, Texas 78539.
2. Exhibit "B"- Bid Page and Products- Bid Page and Products to now include any fees for additional services described herein, subject to the limitations of the Contract.

3. Except as modified herein, all terms and conditions of the CONTRACT, as amended, remain in full force and effect. COUNTY and SELLER ratify and confirm the terms and provisions of the CONTRACT as amended herein.
