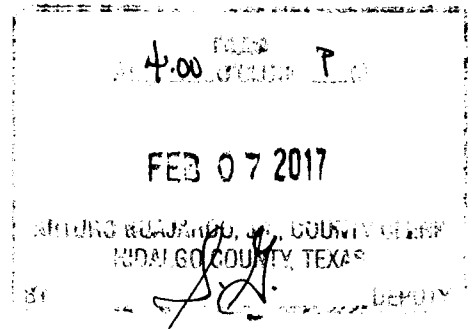

**FIRST AMENDMENT TO AGREEMENT
C-14-321-12-16**

THIS AMENDMENT TO THE AGREEMENT, is made this 6th day of February, 2017 by and between HIDALGO COUNTY, TEXAS (the "County") and PALM VALLEY ANIMAL CENTER (the "Contractor").

WHEREAS, County and Contractor entered into an Agreement dated January 1, 2015, in which Contractor was to provide the facilities and services of a local animal shelter pursuant to Chapter 826, Texas Health & Safety Code; and

WHEREAS, County agreed to pay monthly installments, beginning January, 2015 and ending December, 2017, as consideration for the services provided by Contractor;

WHEREAS, on November 15, 2016, Contractor advised County that circumstances related to the performance of the Agreement had changed, requiring the need for additional funding to perform Contractor's obligations under the Agreement;

WHEREAS, County and Contractor now desire to amend the Agreement as hereinafter provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Contractor hereby agree to the following amendments to the Agreement:

1. County agrees to pay a total sum of Seven Hundred and Eighty Nine Thousand Eight Hundred and Fourteen Dollars and 00/100ths (\$789,814.00), for services provided for and on behalf of the County under the Agreement, for the year 2017;
2. This total sum (\$789,814.00), shall be payable in twelve (12) equal monthly installments of Sixty Five Thousand Eight Hundred Seventeen Dollars and 83/100ths (\$65,817.83) through the remaining term of the Agreement beginning in January 2017 and ending December 31, 2017;
3. Paragraph 4. of the Agreement shall be modified to reflect the following change for year 2017:

2017 year = \$65,817.83 per month (\$789,814.00/year)

4. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and the County and the Contractor ratify and confirm the terms and provisions of the Agreement as amended.
