This AMENDMENT ONE (1) modifies the Memorandum of Understanding (16-3633124) entered into by and between the Texas A&M Health Science Center, a health-related institution under the administration of Texas A&M University, a member of The Texas A&M University System and an agency of the State of Texas, on behalf of the Texas A&M School of Public Health Community-Based Pediatric Asthma Education and Intervention Program (hereinafter referred to as "HSC-SPH"), and Hidalgo County Head Start Program (hereinafter referred to as "HCHSP") effective on June 30, 2016.

NOW THEREFORE, the Parties agree to amend the original Agreement as follows:

Center Sites. The names and addresses of the HCHSP sites to be serviced by HSC-SPH Community-Based Pediatric Asthma Education and Intervention Program are expanded. The revised inclusive Center Directory is hereby incorporated and appended as Exhibit A.

Term. HSC-SPH and HCHSP agree to renew the Agreement term for one additional year. The amended period of performance is September 1, 2015 through December 31, 2018.

Except as provided herein, all terms and conditions of the original Agreement remain unchanged and in full force and effect. In witness thereof, the Parties have executed this document on the day and year last specified below.
