

**RATIFICATION OF TRANSFER OF JUSTICE OF THE PEACE PRECINCT 2, PLACE
2, DUTIES AS LOCAL REGISTRAR TO THE CLERK OF THE COUNTY OF
HIDALGO, TEXAS**

WHEREAS, Section 191.021, Subsection (a)(1) Texas Health and Safety Code, provides that the Office of the Justice of Peace Precinct 2, Place 2 is the local registrar of births and deaths in Precinct 2 of the County of Hidalgo, Texas; and

WHEREAS, Section 191.022, Subsection (a) provides that the a justice of the peace may transfer the duty of registering births and deaths to a county clerk if the justice of the peace and the county clerk agree in writing and the agreement is ratified by the commissioners court; and

WHEREAS, The office of Jaime Jerry Munoz, the Justice of the Peace, Precinct 2, Place 2, of the County of Hidalgo, Texas desires to consolidate the birth, death, and fetal death records of the precinct and the County of Hidalgo, Texas; and

WHEREAS, the office of Arturo Guajardo, Jr., Clerk of the County of Hidalgo, Texas, desires to consolidate the birth, death, and fetal death records of the precinct and the County of Hidalgo, Texas; and

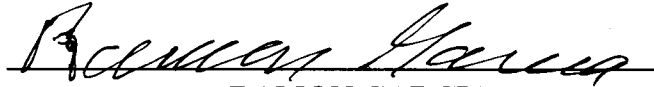
WHEREAS, the office of Jaime Jerry Munoz, the Justice of the Peace, Precinct 2, Place 2, of the County of Hidalgo, Texas and office of Arturo Guajardo, Jr., Clerk of the County of Hidalgo, Texas have agreed in writing to undertake such a consolidation of records; and

WHEREAS, the citizens of the County of Hidalgo, Texas would be better served by having all birth, death and fetal death records in a central location, now

Therefore be it RATIFIED, by County Commissioner's Court of the County of Hidalgo, Texas that:

Effective March 21, 2017, the records of the Justice of the Peace of the County of Hidalgo, Precinct 2, Place 2 will be consolidated with the records of the Office of the Clerk of the County of Hidalgo, Texas a local registrar, and all duties imposed by Title 3 of the Texas Health and Safety Code related thereto.
