



RESOLUTION TO TRANSFER THE CITY OF ALTON DUTIES AS LOCAL REGISTRAR TO THE CLERK OF THE COUNTY OF HIDALGO, TEXAS

WHEREAS, Section 191.022, Subsection (a)(1) Texas Health and Safety Code, provides that the municipal clerk or the City Secretary of City of Alton, Texas, which is located in the jurisdictional boundaries of the County of Hidalgo, Texas, is the local registrar of births and deaths in the City of Alton; and

WHEREAS, Section 191.023, Subsection (a) provides that a municipality may transfer the duty of registering births and deaths to a county clerk in which the municipality is located, by adopting a concurring resolution agreeing to transfer and establishing a timetable for the transfer; and

WHEREAS, the City of Alton, Texas desires to consolidate the birth, death, and fetal death records of the City of Alton precinct to the Clerk of the County of Hidalgo, Texas; and

WHEREAS, the City of Alton, Texas has adopted a concurring resolution at the regular meeting of the City of Alton Council Meeting on March 24, 2015; and

WHEREAS, the office of Arturo Guajardo, Jr., Clerk of the County of Hidalgo, Texas, desires to consolidate the birth, death, and fetal death records of the City of Alton, Texas, and has sufficient resources and finances to assume those duties; now

THEREFORE BE IT RESOLVED, by the County Commissioner's Court of the County of Hidalgo, Texas that the City of Alton, Texas and the County of Hidalgo, Texas, by and through the Office of Arturo Guajardo, Jr., Clerk of the County of Hidalgo, Texas have agreed to undertake such a consolidation of the birth, death, and fetal death records of the City of Alton and the County of Hidalgo, Texas.
