**HIDALGO COUNTY SHERIFF'S OFFICE  
EMERGENCY MEDICAL PROGRAM  
AFFILIATION AGREEMENT FOR EMS PERSONNEL**

THIS Agreement is made this 22 day of MAY 2017, by and between the **COUNTY OF HIDALGO, TEXAS** By and Through the **HIDALGO COUNTY SHERIFF'S OFFICE EMERGENCY MEDICAL PROGRAM**, a unit of local government in the State of Texas, hereinafter referred to as "**HCSO-EMP**" and **HIDALGO COUNTY EMS**, hereafter referred to as "**HIDALGO COUNTY EMS**".

WHEREAS, the HCSO-EMP operates an Emergency Medical Technology Program; and

WHEREAS, HCSO-EMP desires to have personnel of its EMT Program participate in a clinical training program at HIDALGO COUNTY EMS's facility; and

WHEREAS, HIDALGO COUNTY EMS and HCSO-EMP recognize the need for well-trained and experienced EMS personnel and believe that the clinical training program will be of great benefit and service to HIDALGO COUNTY EMS, HCSO-EMP and the citizens of Hidalgo County; and

WHEREAS, the clinical training program will provide EMS personnel a wide range of experience and training necessary to provide quality emergency medical care.

NOW, THEREFORE, the parties hereto agree as follows:

**1. Joint Responsibilities.**

- (a) All parties will cooperate to provide EMS personnel with a proper learning opportunity.
- (b) All parties will agree on the number of EMS personnel receiving their clinical training at the HIDALGO COUNTY EMS, with consideration given to the number of EMS personnel, the opportunities for training and experience at HIDALGO COUNTY EMS, and the quality of care afforded to HIDALGO COUNTY EMS's patients.
- (c) All parties will agree on a clinical schedule that shall include a list of students and where they will be scheduled for the rotation.

**2. Responsibilities of the HCSO-EMP.**

- (a) The EMS personnel will abide by the policies of HIDALGO COUNTY EMS while using its facilities, which policies will be provided in writing to the HCSO-EMP and each participating member of the EMS staff.

- (b) The HCSO-EMP will emphasize to the HIDALGO COUNTY EMS personnel the importance of respecting the confidential nature of all information that may be made available to them with respect to patients and hospital records and agrees to abide by all required state and federal law regarding same.
- (c) To the extent permitted under the Constitution and laws of the State of Texas, HCSO-EMP agrees to defend, indemnify and hold harmless HIDALGO COUNTY EMS, its officers, agents, trustees, employees, and any other person, firm or corporation bound to defend or pay judgments against said party from and against any and all claims, demands, or causes of action including claims for attorney's fees and contribution or indemnity, which arise due to negligence on the part of its agents, servants, or employees, including, but not limited to EMS personnel, in the performance of any of its obligations under this Agreement.
- (d) A copy of the professional liability insurance policy carried by the HCSO-EMP on its EMS personnel will be furnished to the HIDALGO COUNTY EMS.
- (e) HCSO-EMP's Director of the EMT Program or designee will evaluate and counsel EMS personnel with regard to performance.
- (f) The EMS Director or designee is responsible for direct supervision of the EMS personnel.
- (g) EMS personnel will provide their own uniforms.
- (h) The EMS Director or designee will assume responsibility for administrative functions related to EMS personnel attendance and evaluation.
- (i) The HCSO-EMP will maintain on file for quick reference at its EMS offices, the following information:
  - P.P.D. skin test for Tuberculosis done within the previous six (6) months or a chest x-ray (PA and Lat) and a complete TB questionnaire form prescribed by HIDALGO COUNTY EMS, and
  - Up-to-date immunizations for MMR (measles, mumps, rubella). (Hepatitis B and influenza are strongly recommended.)
  - List of Names of students and immunizations.
- (j) HCSO-EMP will inform its EMS personnel that they are not considered employees of the HIDALGO COUNTY EMS and that they are not authorized to represent themselves as employees of HIDALGO COUNTY EMS.
- (k) The HCSO-EMP agrees to inform its EMS personnel that they are not subject to coverage by HIDALGO COUNTY EMS's Workmen's Compensation Program.
- (l) The EMS Director or designee will supply HIDALGO COUNTY EMS, at least (30) thirty days in advance, with a schedule of the EMS personnel who wish to participate in the program and the times they will be present at the HIDALGO COUNTY EMS.

- (m) The EMS Director or designee will supply HIDALGO COUNTY EMS with a list of skills for personnel at each level of certification prior to clinical rotation.

### **3. Responsibilities of the HIDALGO COUNTY EMS.**

- (a) The HIDALGO COUNTY EMS will, at its sole discretion, permit said EMS personnel to observe its routines and procedures in HIDALGO COUNTY EMS's Emergency Medical Service under the direct supervision of HIDALGO COUNTY EMS personnel, licensed or qualified employees of the HIDALGO COUNTY EMS and self-study program instructor who will spot check students.
- (b) The HIDALGO COUNTY EMS agrees to assist the program by providing through its supervisory personnel assistance with task sheets, attendance and evaluation sheets, at intervals to be agreed upon.
- (c) The HIDALGO COUNTY EMS will orient the EMS Director or designee and EMS personnel to HIDALGO COUNTY EMS facilities and policies.
- (d) The HIDALGO COUNTY EMS will inform its professional staff of its participation in the program.
- (e) The HIDALGO COUNTY EMS will assume full responsibility for patient care.
- (f) The HIDALGO COUNTY EMS reserves the right, in its absolute discretion, to refuse its facilities and services to any EMS personnel who do not meet the professional standards proposed by the HIDALGO COUNTY EMS.
- (g) HIDALGO COUNTY EMS agrees to defend, indemnify and hold harmless HCSO-EMP, its officers, agents, elected officials, employees and any other person, firm or corporation bound to defend or pay judgments against said party from and against any and all claims, demands or causes of action including claims of attorney's fees and contribution or indemnity which arise due to negligence on the part of its agents, servants, or employees in the performance of any of its obligations under this Agreement.
- (h) HIDALGO COUNTY EMS will designate a person or persons with whom all EMS personnel are to report upon arrival for and departure from the training program.

### **4. Miscellaneous.**

- 4.1** This Agreement may be modified at any time upon the written requests of either party with the consent of the other party.
- 4.2** This Agreement is to remain in effect unless revisions are made, or as Changes are deemed necessary.
- 4.3** The interpretation and enforcement of this Agreement shall be governed by the laws of the State of Texas and this Agreement is performable in Hidalgo County, Texas.

**4.4** Any notices required by this Agreement shall be deemed made on the day personally delivered in writing or mailed by certified mail, postage prepaid, to the other party at the address set forth below or to such other persons and address as either party may designate in writing:

**4.5** The invalidity or unenforceability of any provisions of this Agreement will not affect the validity or enforceability of any other provision.


**4.6** The defined terms used herein are for convenience only and do not limit the contents of this Agreement.






