2. That on the date of such signing and on the date hereof, we were and are the duly chosen, qualified and acting officers of the County authorized to execute the same;
3. No litigation of any nature is now pending or to the best of our knowledge, threatened, either in the state or federal courts, contesting or attacking the existence of the County, the boundaries of the County, or the Certificates or restraining or enjoining the issuance of the Certificates or the collection or pledge of the funds from which the Certificates are payable, or in any manner questioning the authority or proceedings of the issuance, execution or delivery of the Certificates, or affecting the titles of the present officials of the County, and that no proceedings or authority for the issuance, execution or delivery of the Certificates have been repealed, rescinded or revoked;
4. That no litigation of any nature is now pending or to the best of our knowledge, threatened, either in the state or federal courts, that would affect the authority for the issuance of the Certificates or the assessment or collection of taxes pledged to pay the principal of and interest on the Certificates;
5. That the seal which has been impressed, or placed in facsimile, upon the Certificates is the legally adopted, proper and only official seal of the County, said official seal being impressed on this certificate; and
6. That all the proceedings for the issuance of the Certificates as adopted by the officers of the County have not been amended, repealed, or rescinded since the date of their passage, and all such proceedings relating to the issuance of the Certificates remain in full force and effect as of the date of this certificate.

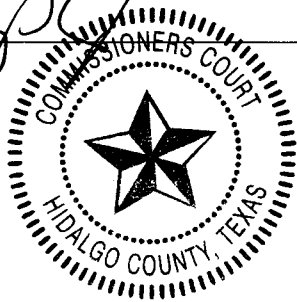

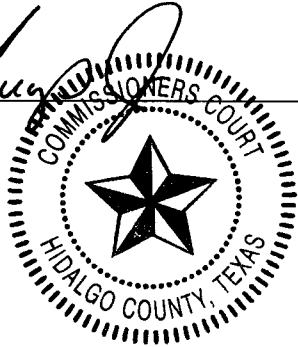
