**FIRST AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT BETWEEN CAMERON COUNTY AND HIDALGO COUNTY**

This First Amendment to Interlocal Cooperation Agreement is made on this the \_\_\_\_ day of \_\_\_\_\_, 2017 by and between the County of Cameron hereinafter referred to as the "Cameron", and the Hidalgo County hereinafter referred to as "Hidalgo", pursuant to the provisions of the Texas Interlocal Cooperation Act, as follows:

**WITNESSETH:**

**WHEREAS**, Cameron and Hidalgo entered into an Interlocal Cooperation Agreement (the "Agreement") dated May 16, 2017 regarding reconstruction of a portion of Mile 3 East road (the "Road"), such reconstruction more particularly described in the Agreement; and

**WHEREAS**, as a result of a scrivener's error numbered paragraph 1 of the Agreement incorrectly describes the work to be performed as overlay of the Road.

**NOW, THEREFORE**, for and in consideration of the mutual obligations of the parties herein and other good and valuable consideration the receipt of which hereby acknowledged, Cameron and Hidalgo hereby mutually agree to the following:

1. Numbered paragraph 1 is deleted in its entirety and the following is inserted in lieu thereof:

Hidalgo, through its Precinct 1, will provide the materials, equipment and labor necessary to reconstruct the Road in accordance with plans and specifications mutually agreed to by Cameron County Staff Engineer and Hidalgo County engineer.

2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and County and Cameron ratify and confirm the terms and provisions of the Agreement, as amended.
