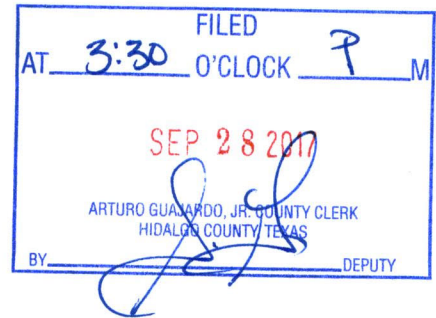

AMENDMENT No.1

TO

**AGREEMENT BETWEEN THE COUNTY OF HIDALGO
AND NASSRI-WARREN GROUP ARCHITECTS, INC.
(Design and Construction of Memorial Park Phase I)
C-17-184-06-27**

This **AMENDMENT** (the "Amendment"), dated the **19th** day of **September, 2017**, is between **NASSRI-WARREN GROUP ARCHITECTS, INC.**, a Texas corporation (the "Architect"), and **HIDALGO COUNTY, TEXAS** (the "Owner"), and amends the Agreement (as such term is defined below).

WHEREAS, Architect and Owner executed that certain Agreement made as of the 27th day of June, 2017, in which the Architect agreed to provide professional services for the Owner's project for the Design and Construction of Memorial Park Phase I (the "Project") located at 107 Highway and Sunflower Road, Edinburg, Texas 78539 (the "Agreement");

WHEREAS, the Architect and Owner have agreed to amend the Agreement as set forth herein to (i) modify the scope of services being provided by the Architect pursuant to the Agreement in order to include certain civil engineering services as Basic Services (as defined in the Agreement) being provided pursuant to the Agreement and (ii) make related changes, including increasing the compensation to the Architect by the amount of the fee for the civil engineering services to South Texas Infrastructure Group, LLC, a Texas limited liability company, which is the engineer providing such civil engineering services for the Project as a subcontractor of the Architect;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Owner and Architect hereby agree as follows:

1. **Amendments.** The Agreement is amended as follows:
 - a. Section 3.1.7.3 of the AIA Document B101-2007 Standard Form of Agreement Between Owner and Architect (the "B101") of the Agreement is deleted and replaced with the following:

§ 3.1.7.3 Civil Engineering Services (which means the services enumerated under the Bid Documents, Bid Assistance and

Construction Phase Services for Civil Engineering sections on Exhibit D-1);

b. Section 11.1 of the B101 is amended to read as follows in its entirety:

§ 11.1 For the Architect's Basic Services described under Article 3, the Owner shall compensate the Architect as follows:

The aggregate amount of Eighty-Five Thousand, Eight Hundred Thirty-Six Dollars and Zero Cents (\$85,836.00).

(The parties acknowledge the aggregate amount is the sum of the original compensation of Eighty Thousand Dollars and Zero Cents (\$80,000.00) plus Five Thousand, Eight Hundred Thirty-Six Dollars and Zero Cents (\$5,836.00), added pursuant to that certain first amendment to this Agreement that included Civil Engineering Services as part of Basic Services.)

c. Exhibit C of the Agreement is amended by adding the insurance certificate attached as Exhibit I hereto at the end thereof. References in the Agreement to "Exhibit C" shall be deemed to be to Exhibit C as amended hereby to include the certificate attached hereto as Exhibit I.

d. Exhibit D of the Agreement is amended by including at the end thereof Exhibit D-1, which is attached hereto as Exhibit II and made a part of the Agreement. References in the Agreement to "Exhibit D-1" shall be deemed to be to the Exhibit D-1 attached hereto as Exhibit II and references in the Agreement to "Exhibit D" shall be deemed to be to Exhibit D" as amended hereby to include such Exhibit D-1.

2. **Ratification.** Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect, and Architect and Owner ratify and confirm the terms and provisions of the Agreement, as amended by this Amendment.



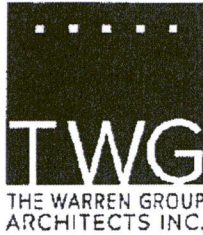

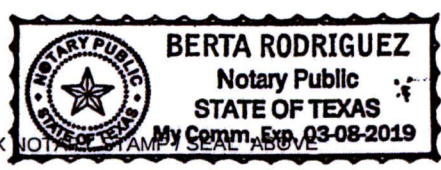
