RURAL EMERGENCY SERVICES**

This **AMENDMENT No. 2** to the **INTERLOCAL AGREEMENT** by and between **CITY OF SULLIVAN** ("hereinafter referred to City/Entity") and **HIDALGO COUNTY, TEXAS** ("hereinafter referred to as HIDALGO") is entered into between the parties effective this **31th** day of **October, 2017**.

WHEREAS, City of Sullivan and Hidalgo entered into an Interlocal Agreement effective **January 1, 2016** in which City of Sullivan agreed to provide: "**Rural Emergency Services**" for Hidalgo County (the "Agreement");

WHEREAS, the parties desire to amend the Agreement as hereinafter provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Hidalgo and City of SULLIVAN hereby agree to the following amendment as set forth below:

4.2.1 ADMINISTRATION shall be amended to include:

- "I. Facilitate use of the Hidalgo County Emergency Alert System – Everbridge, by the Entity, to alert their Volunteer Fire Fighters of an emergency incident within the Entity jurisdiction and/or Rural Response District."

Except as modified or substituted herein, all terms and conditions of the Agreement, as amended, remain in full force and effective and Entity and County ratify and confirm the terms and provision of the Agreement.
