**SECOND AMENDMENT TO INTERLOCAL COOPERATION CONTRACT BETWEEN
HIDALGO COUNTY AND THE UNIVERSITY OF TEXAS HEALTH SCIENCE
CENTER AT HOUSTON**

This AMENDMENT to the Interlocal Cooperation Contract, made on this 31st day of October, 2017, between University of Texas Health Science Center at Houston hereinafter referred to (“UT Health”) and the County of Hidalgo, Texas (“County”), referred to collectively, as the (“Parties”), pursuant to the provisions of the Texas Interlocal Cooperation Act, Texas Govt. Code 791.001 et seq., (“Act”) as follows:

WHEREAS, UT Health and County executed the Interlocal Cooperation Contract, on October 11, 2016, in which the County agreed to serve as the Anchor entity for the Regional Healthcare Partnership, Region 5 the (“Contract”); and

WHEREAS, due to the continuation of the program the Parties desire to extend the term of the Contract under Paragraph VII. *Term of the Contract*; and

WHEREAS, the parties desire to amend the Contract as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and UT Health hereby agree to the following amendment to the Contract:

1. The term of this Contract shall be extended and shall terminate on April 30, 2018.
2. Except as modified herein, all terms and conditions of the Contract, as amended by this Second Amendment, remain in full force and effect and UT Health and County ratify and confirm the terms and provisions of the Contract, as amended herein.
