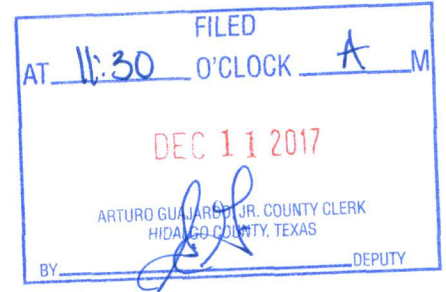


**RESOLUTION**
