**AMENDMENT #2  
TO MEMORANDUM OF AGREEMENT BETWEEN HIDALGO COUNTY AND THE  
UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT HOUSTON-  
BROWNSVILLE CAMPUS**

This **AMENDMENT** to the Memorandum of Agreement is made on this the 19<sup>th</sup> day of December, 2017 between University of Texas Health Science Center at Houston by and through its School of Public Health, (the Regional Academic Health Center in the Lower Rio Grande Valley) hereinafter referred to (“the SPH-B”) and **HIDALGO COUNTY, TEXAS** (“COUNTY”).

**WHEREAS**, SPH-B and County executed the Memorandum of Agreement, between SPH-B, and the County on June 2, 2015, in which the County agreed to provide Use of Office Space and for cooperative efforts between both institutions in the field of chronic care and diabetes management. (the “Agreement”); and

**WHEREAS**, SPH-B and the County shall seek to continue this program and the efforts addressing chronic care and diabetes management; and

**WHEREAS**, the parties desire to amend the Agreement as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and SPH-B hereby agree to the following amendment(s) to the Agreement:

1. The Agreement shall be extended to December 31, 2018.
  
2. Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect and SPH-B and County ratify and confirm the terms and provisions of the Agreement, as amended by this Amendment.

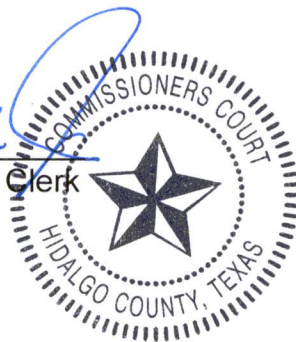
