**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT**

This Amendment to the Professional Service Agreement by and between Hidalgo County, Texas acting by and through its Urban County Program ("County") and Raba Kistner Consultants, Inc. ("Engineer") is entered into between the parties effective this \_\_\_ th day of \_\_\_\_\_, 2018.

**WHEREAS**, County and Engineer entered into that certain Professional Services Agreement dated effective the 18<sup>th</sup> day of April, 2017, (the "Agreement") in which County contracted with Engineer to provide material testing services for the Delta Area Connector East Lateral Project Phase I and Phase III.

**WHEREAS**, the parties desire to amend the Agreement to state the maximum estimated costs of material testing services for Phase I and Phase III of the Delta Area Connector East Lateral Project.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein and, for other good and valuable and consideration, the receipt and sufficiency of which are hereby acknowledged, Engineer and County hereby agree to the following amendment to the Agreement:

1. The following sentence shall be inserted as the last sentence of numbered paragraph 4 of the Agreement.

Compensation for rendering the services for Phase I of the Delta Area Connector East Lateral shall not exceed the sum of Twelve Thousand Seven Hundred Two and forty one hundredths Dollars (\$12,702.41) and the compensation for Services for Phase III of the Delta Area Connector East Lateral Project shall not exceed the sum of Eleven Thousand Nine Hundred Twenty and seventy six one hundredths Dollars (\$11,920.76).

2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect. Employer and Employee and confirm the terms and provisions of the Agreement as amended.
