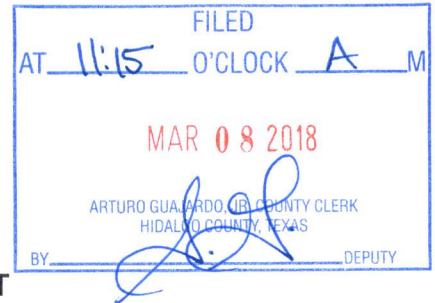

**FIRST AMENDMENT TO SERVICE CONTRACT  
(C-16-035-01-05)**

This **FIRST AMENDMENT** to Service Contract for “**Broadcasting Commissioners’ Court Meetings**” is made this **20th** day of **February, 2018** by and between **Hidalgo County** Texas (“County”) and **MBTV Texas Valley LLC d/b/a R Communications** (“Company”).

**WHEREAS**, Company and County entered into a Contract dated January 05, 2016, in which Company agreed to provide certain services for the purpose of “Broadcasting Commissioners’ Meetings” for Hidalgo County (the “Contract”);

**WHEREAS**, the County and Company have agreed to amend the Contract to amend Exhibit B-1 (Bid Page) to reflect the discounted price; to continue for so long as Company can resume broadcasting Hidalgo County Commissioner Court meeting as provided in the Contract.

**WHEREAS**, the parties desire to amend the Contract as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1.       Numbered paragraph six (6) is deleted in its entirety and the following is substituted in lieu thereof until such time as Company is able to broadcast Hidalgo County Commissioners Court meetings as provided for in the Contract:  
As consideration for securing the Service provided for in this Contract, the County agrees to pay Company the amounts specified in Exhibit “B-1” attached hereto and incorporated herein payable against written invoice submitted by Company
2.       Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. County and Contractor ratify and confirm the terms and provisions of the Contract as amended.
