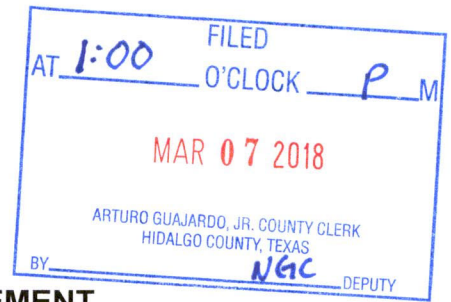

**FIRST AMENDMENT TO LETTER OF ENGAGEMENT
(E-17-257-12-19)**

This **AMENDMENT** to Letter of Engagement (LOE) for “**Independent Audit Services for Hidalgo County**” and Burton McCumber & Longoria, LLP is made this **20th** day of **February, 2018**, between the parties, as follows:

2. Except as modified herein, all terms and conditions of the LOE, as amended, remain in full force and effect and Company and County ratify and confirm the terms and provisions of the LOE as amended.
