1. I understand that Canine Endy was found to be unsuitable for future police work and retired due to medical condition which consists of hip dysplasia.
2. Upon the signing of this form, the County of Hidalgo relinquishes all right, title and interest in said dog and all responsibility for its condition and actions.
3. Therefore, I will indemnify and hold harmless the County of Hidalgo and the Hidalgo County Sheriff's Office, its agents and employees of any and all claims which I, my heirs, executors, or assigns may now or at any time in future from any cause or in any manner connected with the condition or conduct of said canine.
4. I further state that I have not exchanged money or anything else of value except my agreement made herein for the said dog.
5. Further, I accept Canine Endy knowingly that the County of Hidalgo and the Hidalgo County Sheriff's Office makes no warranty or guarantee of its condition of health or temperament, or its future behavior.
6. Considering the above, I understand that the County of Hidalgo assumes no liability for damages to the property of the done, or for personal injuries, disabilities or death of the done or any other person arising from or incident to the donation of this animal or its use or disposition. The done shall hold the County of Hidalgo and the Hidalgo County Sheriff's Office harmless from any and all such lawsuits, actions, or claims of nature arising from or out of the donation of this animal.

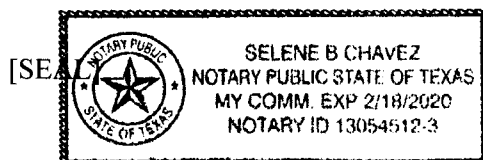

I will also be receptive and cooperative with the Hidalgo County Sheriff's Office at any time to go by my residence and check on the condition of the retired canine. I would appreciate the County's consideration in allowing K9 Endy to spend the rest of his life with me and my loving family.

Canine officer Endy has had hip problems for several years and they continue to worsen. For the past several annual and semi annual exams we have not tested his hips because of the pain. Endy tires easily from the pain and is unable to physically jump up on objects well anymore. He should be on pain medications and joint supplements to ease his pain. The medications necessary need to be long term. I recommend that he retire since he is unable to physically perform his job.
