**FIRST AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT BETWEEN
THE CITY OF ELSA AND HIDALGO COUNTY, TEXAS**

This First Amendment to Interlocal Cooperation Agreement is made on this the 1 day of March, 2018 by and between the City of Elsa, hereinafter referred to as the "City" and Hidalgo County, Texas hereinafter referred to as the "County", as follows:

WITNESSETH:

WHEREAS, the City and County entered into that certain Interlocal Cooperation Agreement by and between City and County dated January 15, 2018 (the "Agreement") regarding the overlay of Mile 171/2 road; and

WHEREAS, the parties desire to clarify that City's payment of the cost of materials shall be made from City's allocation of CDBG funds;

NOW, THEREFORE, for and in consideration of the mutual obligations of the parties herein and other good and valuable consideration the receipt of which hereby acknowledged, the District and County hereby mutually agree to the following:

1. Numbered paragraph 4 is deleted in its entirety and the following is inserted in lieu thereof:

City agrees to use CDBG Funding for City's one-half share of the costs of materials needed for the overlay of the Road which is estimated to be the sum of Twenty Thousand Four Hundred Seventy Six and 50 one hundredths Dollars (\$20,476.50). City shall pay the estimated cost of such one-half of the materials on execution of this Agreement.

2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and County and District ratify and confirm the terms and provisions of the Agreement, as amended.

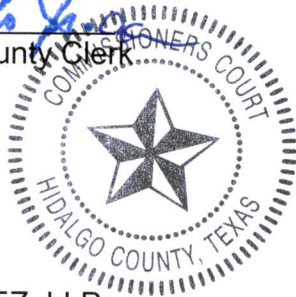

1.
