**ORDER REGULATING PARKING IN THE PARKING LOT OF THE HIDALGO COUNTY FORENSICS CENTER BUILDING AND PROVIDING FOR TOWING AND STORAGE OF UNAUTHORIZED PARKED VEHICLES**

**WHEREAS**, the Commissioners Court of Hidalgo County, at a duly called and noticed meeting on the \_\_\_\_\_ day of \_\_\_\_\_ 2018, and pursuant to Texas Local Government Code Section 615.001, voted to regulate vehicle parking In the parking lot of the Hidalgo County Forensics Center Building located at 3100-A S. Business Hwy 281, Edinburg, Texas (the "Parking Lot");

**WHEREAS**, Hidalgo County is experiencing unauthorized vehicles parked for non business reasons in spaces at the Parking Lot; and

**WHEREAS**, Section 615.001 of the Texas local Government Code provides the commissioners court may regulate the parking of vehicles on property owned or leased by the county including the towing and storage of a vehicle at the vehicle owner's expense if the vehicle Is parked in violation of rules adopted under section 615.001 of the Texas Local Government Code;


**THEREFORE, BE IT NOW ORDERED BY THE HIDALGO COUNTY COMMISSIONERS COURT** that parking in the Parking Lot of the Hidalgo County Forensics Center Building is regulated as follows:


1. Parking Spaces in the Parking Lot marked Hidalgo County Forensics Center parking are limited to vehicles of the office or person(s) to whom the parking space is assigned, and/or person whom are conducting business with the Hidalgo County Forensics Center.
2. Unauthorized vehicles parked in a designated Hidalgo County Forensics Center parking space in the Parking Lot between the hours of 7:00 a.m. to 6:00 p.m. Monday through Friday other than a County of Hidalgo holiday shall be towed and stored from the Parking Lot at the vehicle owner's expense.


3. Unauthorized vehicles parked in driveway to garage sally-port entrance between the hours of 12:00 a.m. to 11:59 p.m. Monday through Friday shall be towed and stored from the Parking Lot at the vehicle owner's expense.
4. Appropriately worded sign(s) shall be placed at the East entrance, North Side and West Sides to the Parking Lot to inform drivers of vehicles of the prohibition of parking vehicles in designated spaces and those vehicles parked in such spaces will be towed and stored at the vehicles owner's expense.


This ORDER being adopted, the County Judge is authorized to sign the ORDER and the County Clerk is instructed to record the ORDER in the official minutes of the Commissioners Court.


