**SECOND AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT
BETWEEN THE CITY OF ELSA AND HIDALGO COUNTY, TEXAS**

This Second Amendment to Interlocal Cooperation Agreement is made on this the ____ day of _____, 2018 by and between the City of Elsa, hereinafter referred to as the "City" and Hidalgo County, Texas hereinafter referred to as the "County", as follows:

WITNESSETH:

WHEREAS, the City and County entered into that certain Interlocal Cooperation Agreement by and between City and County dated January 15, 2018 (the "Agreement") regarding the overlay of a portion of Mile 17 1/2 road; and

WHEREAS, the parties executed an amendment to the Agreement to clarify that City's payment of the cost of materials shall be made from City's allocation of CDBG funds; and

WHEREAS, the parties desire to revise and shorten the length of the portion of the Road of which is to be overlaid.

NOW, THEREFORE, for and in consideration of the mutual obligations of the parties herein and other good and valuable consideration the receipt of which hereby acknowledged, the District and County hereby mutually agree to the following:

1. Numbered paragraph 1 is deleted in its entirety and the following is inserted in lieu thereof:

The parties agree to cooperate in overlaying approximately 3000 liner feet of Mile 17 ½ beginning 1250 linear feet west of FM 88 to 125 linear feet west of FM 88 and resuming 125 linear feet east of FM 88 and ending 2000 linear feet east of FM 88 for a total overlay of approximately 3000 liner feet.

2. Numbered paragraph 4 is deleted in its entirety and the following inserted in lieu thereof.
3. City will provide at the expense of City one-half of the cost of material, required for the overlay of the Road and will pay County on execution of this Agreement the sum of Nineteen Thousand Forty-Seven and 35 one hundredths Dollars (\$19,047.35) for materials which is the one-half of the estimated cost of the materials for the overlay of the Road.
4. Exhibit A to the Agreement is deleted in its entirety and Exhibit A attached hereto is substituted in lieu thereof.



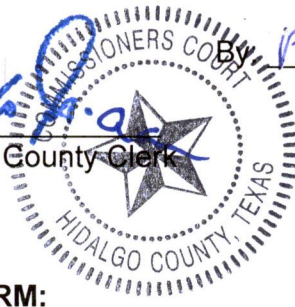
