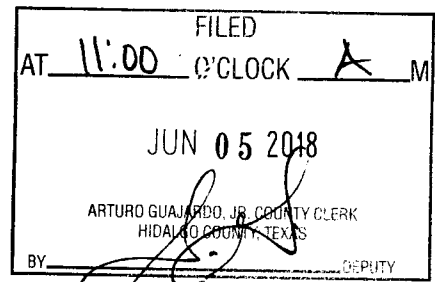

**AMENDMENT TO INTERLOCAL AGREEMENT  
BETWEEN  
THE CITY OF MCALLEN, TEXAS  
AND  
THE COUNTY OF HIDALGO, by and through the  
Department of Health and Human Services**

**WHEREAS**, on March 20, 2018 City of McAllen, Texas and County of Hidalgo, by and through the Department of Health and Human Services entered into an Interlocal Agreement;

**WHEREAS**, the Agreement was for the purpose of providing the joint event of the State of Texas Active Response to Zika II Binational Conference for personnel, including binational personnel from public health, emergency response managers, first-line supervisors and administrators who will function as incident commanders, emergency management coordinators, public utility workers, local stakeholders at all levels of government, public health, non-profit organizations, and any other entity including the volunteers from the general public who respond and provide services in cases of emergencies involving potential public calamities primarily in mitigation, preparedness, response and recovery;

**WHEREAS**, the parties desire to amend the Interlocal Agreement hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this Amendment to the Interlocal Agreement and for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the City of McAllen, Texas and the County of Hidalgo, by and through the Department of Health and Human Services, effective as of the 8<sup>th</sup> day of May, 2018, hereby agrees to the following amendment to the Agreement:

1. Section "5." of the Agreement is amended, modified, and replaced as follows:

"County shall provide a fee of fifty five thousand dollars (\$55,000.00) to the City of McAllen, Texas for the State of Texas Active Response to Zika II Binational Conference for the conference costs."


2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full all other provisions in the original agreement will remain in effect.




