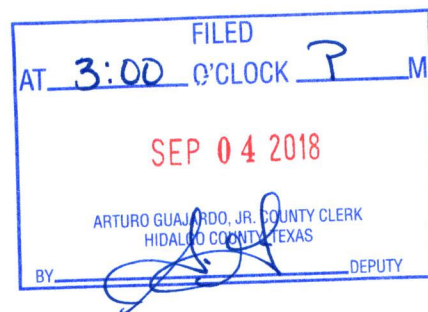

**AMENDMENT TO MEMORANDUM OF UNDERSTANDING  
BETWEEN  
LOWER RIO GRANDE VALLEY DEVELOPMENT COUNCIL  
AND  
THE COUNTY OF HIDALGO**

**WHEREAS**, on July 31, 2018 Lower Rio Grande Valley Development Council and County of Hidalgo entered into a Memorandum of Understanding;

**WHEREAS**, the Agreement was for the purpose of establishing the rights and responsibilities of each party in a public bus transportation project operated under the “Valley Metro” banner that will serve the citizens of Hidalgo County. The goal of the project is to provide access and mobility for County employees, the general public low-income persons, the disabled, the elderly, veterans, and others who require public transit to reach their employment locations, county services, and other destinations.

**WHEREAS**, the parties desire to amend the Memorandum of Understanding as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions of this Amendment to the Memorandum of Understanding and for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the Lower Rio Grande Development Council and the County of Hidalgo effective as of the 4<sup>th</sup> day of September, 2018, hereby agrees to the following Amendment:

1. Section 2. STATEMENT OF SERVICES TO BE PERFORMED:  
subsection “a.” is hereby modified, revised, and/or replaced as follows:
  - a. **LRGVDC will operate a shuttle bus route (Downtown Square Parking Shuttle) in the City of Edinburg, Hidalgo County, Texas. The route, designated by mutual agreement between LRGVDC and COUNTY, shall operate shuttle bus #1 weekday - from 7:00 a.m. to 6:00 p.m.; with service frequencies of five (5) minutes at peak times; shuttle bus #2 - from 7:00 a.m.; till 1:30 p.m.; with service frequencies of five (5) minutes at peak times; for a total of nineteen (19) service hours per day.**

2. Section 3. COST FOR SERVICES; is hereby modified, revised, and/or replaced as follows:

**COUNTY shall provide a local match for Shuttle Service up to an amount of Seventy Seven Thousand Five Hundred and Sixty Nine Dollars and Ninety Six Cents; COUNTY shall provide a local match for Shuttle Optional Cost up to an amount of Eighty Eight Thousand Dollars and No Cents (as outlined in the budget attached herein and incorporated by reference).**

3. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full all other provisions in the original agreement will remain in effect.
