This Amendment to the Memorandum of Understanding by and between the Weslaco Independent School District (the "District") and Hidalgo County through the Head Start Program ("Head Start") effective the ____ day of _____ 2018 is made between the District and Head Start (the "Addendum") as follows:

Whereas, on or about August 28, 2018 the District entered into that certain Memorandum of Understanding (the "Agreement") with Head Start for the provision of providing educational services at certain premises known as:

WHEREAS, the District and Head Start desire to amend the MOU, to add two additional responsibilities for the District.

NOW THEREFORE, for and in consideration of the terms and conditions hereof and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, and this mutually agreed upon amendment to the Agreement; the District and Head Start hereby agree to the following amendments to the Agreement:

1. The following additions shall be inserted in the titled paragraph "Partnership Responsibility", subparagraph A as items n and o.
 - n. Provide one bus to transport students from Airport Elementary to Roosevelt Head Start in Mercedes.
 - o. In case of an emergency, provide Cleckler Elementary as a relocation site for students that attend Weslaco III Head Start. Head Start parents will pick-up students at Cleckler Elementary.

2. Except as modified herein, all terms and conditions of the Agreement, as modified, remain in full force and effect and the District and Head Start ratify and confirm the terms and provisions of the Agreement as amended.

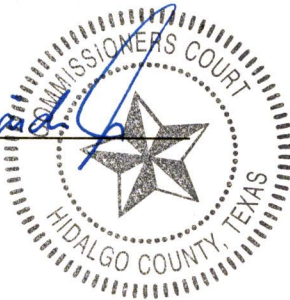
