The purpose of this letter is to exercise Hidalgo County's option to extend a center Interlocal Agreement for two and a half (2.5) additional years as stated in the existing contract dated December 13, 2016 between Hidalgo County and the **Edcouch-Elsa Independent School District (Edcouch Head Start Center)** for the property located at 201 N. Yellow Jacket Drive, Elsa, TX., 78538 (The "Original Interlocal Agreement").

The beginning and ending date of extension shall be January 1, 2019 through June 30, 2021. The original Interlocal Agreement is extended for a period of two and a half (2.5) years with all conditions including the lease amount remaining the same.
