THIRD AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT BETWEEN HIDALGO COUNTY, TEXAS AND HIDALGO COUNTY DRAINAGE DISTRICT NO.1

This Third Amendment to Interlocal Cooperation Agreement ("Third Amendment") is made on this the 06th day of November, 2018 by and between Hidalgo County, Texas acting by and through its Urban County Program hereinafter referred to as the "Program" and Hidalgo County Drainage District No.1 hereinafter referred to as the "District" as follows:

WITNESSETH:

WHEREAS, Program and District entered into that certain Interlocal Cooperation Agreement by and between Program and District dated December 5, 2017 (the "Agreement") regarding the improvement of the Peñitas Lateral drainage ditch;

WHEREAS, the parties desire to amend the Agreement to redesign and construct concrete bases to avoid an existing fiber optic line.

NOW, THEREFORE, for and in consideration of the mutual obligations of the parties herein and other good and valuable consideration the receipt of which hereby acknowledged, the District and County hereby mutually agree to the following:

- 1. The following sentence shall be added to Numbered paragraph 1 of the Agreement:

Drainage District shall within ten (10) days following the date of the last party to execute this Third Amendment contribute the sum of Seventy-Six Thousand Nine Hundred Sixty- Seven and no one hundredths Dollars (\$76,967.00) to be utilized by Program for design and construction of concrete boxes and associated drainage improvements to avoid an existing fiber optic line as shown by Exhibit A attached hereto.

- 2. Except as modified herein, all terms and conditions of the Agreement, as amended. Remain, In full force and effect and County and District ratify and confirm the terms and provisions of the Agreement, as amended.
