**THIRD AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT  
BETWEEN COUNTY OF HIDALGO, TEXAS AND  
CITY OF WESLACO, TEXAS**

This Third Amendment to the Interlocal Agreement is made this 17<sup>th</sup> day of December, 2018, by and between **COUNTY OF HIDALGO, TEXAS**, (“County”), and **CITY OF WESLACO** (“City”).

**WHEREAS**, the City and County entered into an Interlocal Agreement dated July 3, 2018, wherein County will utilize space available within the City of Weslaco for the Justice Courts in Precinct #1 to hold court in the municipal courtroom located at 901 N. Airport Dr., Weslaco, TX 78596 and for the Offices of Commissioner Precinct #1 to continue to operate at Weslaco City Hall located at 255 S. Kansas Ave., Weslaco, TX 78596 (the “Premises”);

**NOW, THEREFORE**, and in consideration of the terms and provisions set forth herein, for other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, City and County hereby agree to the following amendment to the Agreement:

1. The term of the agreement shall be extended to April 1, 2019, by agreement of the parties.
2. Except as modified herein, all other terms and conditions of the Agreement, as amended, remain in full force and effect and City and County ratify and confirm the terms and provisions of the Agreement, as amended.

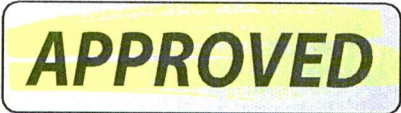
