**AMENDMENT TO THE
INTERLOCAL COOPERATION AGREEMENT BETWEEN
THE COUNTY OF HIDALGO, TEXAS AND THE CITY OF EDINBURG, TEXAS**

THIS AMENDMENT TO THE INTERLOCAL COOPERATION AGREEMENT BETWEEN CITY OF EDINBURG, TEXAS AND THE COUNTY OF HIDALGO, TEXAS (Agreement), by and between the County of Hidalgo, Texas (County) and the City of Edinburg, Texas (City), is entered between the parties this 17th day of December, 2018.

WHEREAS, On or about January 1, 2015, City and County entered into an Agreement regarding the handling and processing or disposal in the City’s landfill of non-hazardous solid waste materials situated in and/or collected by the County’s precincts;

WHEREAS, County requires the disposal of an amount of non-hazardous material (ash); the type of which is not currently covered by the current Agreement.

WHEREAS, on or about May 23, 2018, City approved a *Class II Waste Profile* classifying the material in question and setting the applicable rate for disposal. (See **Exhibit “A”**: *Class II Waste Profile* incorporated herein by reference for all purposes).

WHEREAS, section “C” of the current Agreement provides that the type of waste in question for which City possesses TCEQ acceptance authorization may be accepted at a rate formally approved by agreement of the parties.

WHEREAS, County and City now desire to amend the Agreement as hereinafter provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and City hereby agree to the following amendments to the Agreement:

1. Parties agree that the type of non-hazardous waste as described in the attached **Exhibit “A” – Class II Waste Profile** (ACI Ash) shall be incorporated into part I, section A. Type of Waste of the Agreement and shall be considered a type of waste pursuant to the terms of the Agreement.
2. Parties agree to amend part II, section A. Rates for Disposal of the Agreement to include the rate of the additional type of waste as provided in the attached **Exhibit “A” – Class II Waste Profile** by adding the following:
 7. ACI Ash.....\$17.00 per cubic yard

3. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and the County and the City ratify and confirm the terms and provisions of the Agreement as amended.

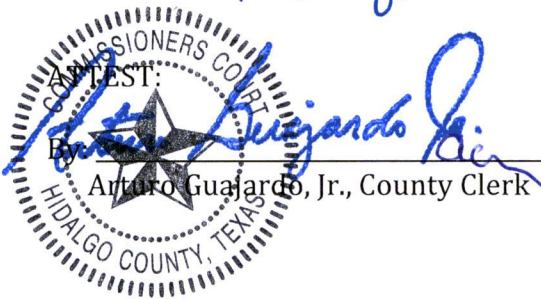
