**AMENDMENT#2  
TO AIA B133-2014  
STANDARD FORM OF AGREEMENT BETWEEN OWNER AND ARCHITECT,  
C-18-025-11-20**

This AMENDMENT to the AIA Document B133-2014, between Rike Ogden Figueroa Alex, Architects, Inc. ("the Architect") and **HIDALGO COUNTY, TEXAS** ("Owner"), effective 24th day of March, 2020, is made between the Architect and the Owner, (the "Amendment"), as follows:

**WHEREAS**, Architect and Owner executed the AIA Document B133-2014, between Architect and the Owner on November 20, 2018, in which the Architect agreed to provide professional services for Design and Construction of Hidalgo County Services Facilities and Justice Center located at 1212 South 25<sup>th</sup> Street, Edinburg, Texas (the "Agreement");

**WHEREAS**, due to a change in circumstances the Architect and Owner have agreed to modify the original scope of services to be provided by the Architect for Design and Construction of Hidalgo County Services Facilities and Justice Center to remove the construction of the Hidalgo County Services Facilities which it includes the reduction of the scope of work and the Architect's fees. Added to the services is to include Landscape Design as described more fully below; and

**WHEREAS**, the parties desire to amend the Agreement as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Owner and Architect hereby agree to the following amendment to the Agreement.

1. The scope of services in the Agreement is modify, and shall be provided, as described in Exhibits A-1 to this Amendment.
2. The Agreement is revised to show the change in the Project name from "Hidalgo County Services Facilities and Justice Center," to "Hidalgo County Precinct No. 4 Justice Center."
3. Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect and Architect and Owner ratify and confirm the terms and provisions of the Agreement, as amended by this Amendment herein.

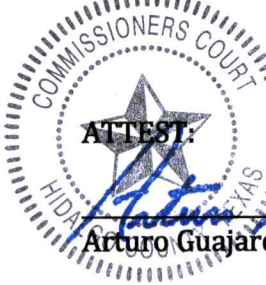
