**INTERLOCAL COOPERATION AGREEMENT BETWEEN
HIDALGO COUNTY AND CITY OF ALTON, TEXAS**

THIS Agreement is made on this the 5th day of May, 2020 by and between **HIDALGO COUNTY, TEXAS**, hereinafter referred to as "County", and **CITY OF ALTON** hereinafter referred to as "City", pursuant to the provisions of the Texas Interlocal Cooperation Act 791., as follows:

W I T N E S S E T H:

WHEREAS, Hidalgo County is a county created in Texas;

WHEREAS, City is a municipality located in Texas;

WHEREAS, City and County desire to assist one another in multiple projects to be defined by mutual agreement in which both the City and the County would benefit from the donation;

NOW, THEREFORE, City and County, in consideration of the mutual covenants expressed hereinafter, agree as follows:

1. County agrees to donate to the City vehicle equipment and accessories owned by County and as further detailed in Exhibit A herein.
2. Prior to County providing City, County vehicle equipment or accessories, City shall request and receive asset transfer form from the County of equipment being transferred.
3. Any request by City for County vehicle equipment or accessories, shall be subject to the approval of the Hidalgo County Commission Court determining that such equipment and materials are not needed or required by the Hidalgo County Sheriff Office.
4. The parties agree that all donated equipment and accessories shall be the responsibility of each respective entity in its entirety.

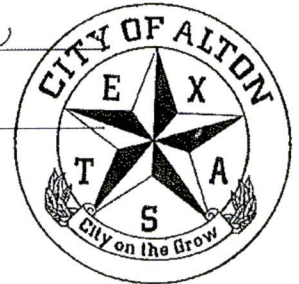
