**AMENDMENT NO. 2 TO INTERLOCAL COOPERATION AGREEMENT BETWEEN  
COUNTY OF HIDALGO AND CITY OF WESLACO, TEXAS**

THIS Amendment to Interlocal Cooperation Agreement (the "Amendment") is made between the County of Hidalgo ("County") and the City of Weslaco, Texas ("City") effective the 12th day of May, 2020, pursuant to the provisions of the Texas Interlocal Agreement Cooperation Act, as follows:

WHEREAS, by Interlocal Agreement dated August 14, 2018, County and City agreed to that certain improvements to Mile 10, North from Mile 6 to FM 1015; and

WHEREAS, following the execution of the Agreement, County and City desire to clarify the monetary contribution by City;

NOW THEREFORE, for and in consideration of the clarification of the Agreement and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, County and City hereby agree to the following amendments to the Agreement:

1. The eighth and ninth "Whereas Clause" of the Agreement are deleted in their entirety and the following is inserted in lieu thereof:

WHEREAS, the total Phase I project development cost is estimated to be One Million Six Hundred Thirty One Thousand Seven Hundred Forty One and Fifty-two Hundredths Dollars (\$1,631,741.52) of which the COUNTY will contribute an estimated amount of Eight Hundred Fifteen Thousand Eight Hundred Seventy and Seventy-six Hundredths Dollars (\$815,870.76).

WHEREAS, the CITY desires to cooperate by contributing a lump sum amount of Eight Hundred Fifteen Thousand Eight Hundred Seventy and Seventy-six Hundredths Dollars (\$815,870.76) to County towards the project development activities.

2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and CITY and COUNTY ratify and confirm the terms and provisions of the Agreement as amended.

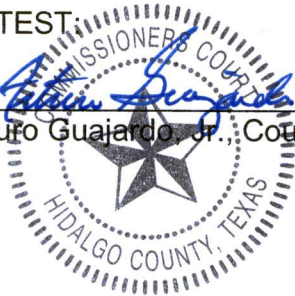
