**AMENDMENT OF SERVICE CONTRACT  
(C-19-269-12-17)**

This **AMENDMENT** of the service contract for “**Professional Consulting Services For Researching, Developing, Writing, Obtaining, and Administering of Grants**” for **Hidalgo County** in connection to contract #**C-19-269**, dated December 17, 2019 and effective January 01, 2020, by and between **THE COUNTY OF HIDALGO, TEXAS** (“County”) and **Hollis Rutledge and Associates, Inc.** (“Consultant”), collectively referred to as (“Parties”) is entered into between the Parties this **30th day of June, 2020**.

**WHEREAS**, Consultant and County entered into a Contract dated **December 17, 2019**, in which Consultant agreed to provide certain services for the purpose of “**Researching, Developing, Writing, Obtaining, and Administering of Grants**” for **Hidalgo County** (the “Contract”); and

**WHEREAS**, the parties agree that the terms stated in paragraph 3 of the Agreement and Exhibit “B” were made in error and therefore it is the intent of the parties to correct the Agreement to reflect the appropriate terms and exhibit as noted below; and

**WHEREAS**, the parties desire to amend the Contract and the Exhibit “B” to reflect the parties actual intent, and

**WHEREAS**, as authorized by the terms of the Agreement, any Amendments will be effective if made in writing and approved by both the County and Consultant.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Consultant hereby agree to the following:

1. The Contract is hereby amended so that, paragraph 3 of the contract is deleted and replaced with the following language to reflect the actual intent of the parties:

2. The Exhibit "B" is hereby deleted and replaced so that, the Rate as noted in Exhibit "B" to the Contract is amended to reflect the actual intent of the parties as follows:

**Rate \$125 hourly (not to exceed 40 hours per month)**

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Consultant and County ratify and confirm the terms and provisions of the Contract as amended.
