**FIRST AMENDMENT TO  
PROFESSIONAL SERVICES AGREEMENT  
C-19-201-08-13**

**THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (“Agreement”)** is made and entered the **14<sup>th</sup>** day of **July 2020**, by and between **HIDALGO COUNTY, TEXAS**, (“County”) and **ROFA ARCHITECTS, INC.** (“Architect”).

**WITNESSETH:**

**WHEREAS** pursuant to Texas Government Code Chapter 2254 (the “Texas Professional Services Procurement Act”), the County requested Statements of Qualifications from professional architect firms to establish a yearly pool to provide **On-Call Architect Services** (the “Services”);

**WHEREAS**, on or about the **13<sup>th</sup>** day of **August 2019**, the County and Architect entered into an agreement (“**Agreement**”) after being pre-qualified from the established pool to provide Services for projects within **Hidalgo County Precinct No. 4**.

**WHEREAS**, it has become necessary to amend the Agreement of the Parties to extend the term of the Agreement for the purpose of maintaining the availability of the professional architect firms to provide services through the time period indicated below; and

**WHEREAS**, County, and Architect now desire to amend the Agreement as hereinafter provided.

**NOW, THEREFORE**, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Architect hereby agree to the following amendment to the Agreement.

1. The term of the Agreement is extended from the original termination date of **August 12, 2020**, as indicated in paragraph five (5) of the Agreement to **December 31, 2020**.

Except as modified herein, all terms and conditions of the Agreement, remain in full force and effect. County

and Architect ratify and confirm the terms and provisions of the Agreement as amended herein.
