**FIRST AMENDMENT TO  
PROFESSIONAL SERVICES AGREEMENT

**THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (“Agreement”)** is made and entered the 21<sup>st</sup> day of **July 2020**, by and between **HIDALGO COUNTY, TEXAS**, (“County”) and **QUINTANILLA HEADLEY & ASSOCIATES** (“Surveyor”).

**WITNESSETH:**

**WHEREAS** pursuant to Texas Government Code Chapter 2254 (the “Texas Professional Services Procurement Act”), the County requested Statements of Qualifications from professional surveying firms to establish a yearly pool to provide **On-Call Surveying Services** (the “Services”);

**WHEREAS**, on or about the 27<sup>th</sup> day of **August 2019**, the County and Surveyor entered into an agreement (“Agreement”) after being pre-qualified from the established pool to provide Services for projects within **Hidalgo County Precinct No. 4**.

**WHEREAS**, it has become necessary to amend the Agreement of the Parties to extend the term of the Agreement for the purpose of maintaining the availability of the professional surveying firms to provide services through the time period indicated below; and

**WHEREAS**, County, and Surveyor now desire to amend the Agreement as hereinafter provided.

**NOW, THEREFORE**, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Surveyor hereby agree to the following amendment to the Agreement.

1. The term of the Agreement is extended from the original termination date of **August 26, 2020**, as indicated in paragraph five (5) of the Agreement to **December 31, 2020**.

Except as modified herein, all terms and conditions of the Agreement, remain in full force and effect. County
