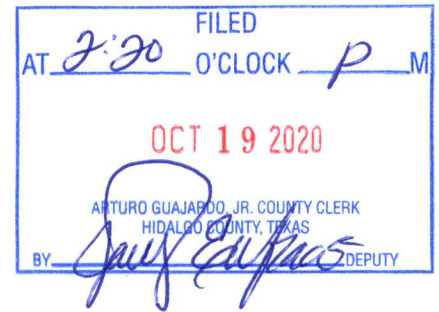

**AMENDMENT No. 1 TO
SERVICE AGREEMENT
C-20-090-05-19**



This AMENDMENT to Services Agreement (“Agreement”) is made this 6th day of October, 2020, by and between and the **COUNTY OF HIDALGO, TEXAS** hereinafter referred to as “County”, by and through the Hidalgo County Precinct 4, and **DICE Productions** hereinafter referred to as “Vendor”.

WHEREAS, Vendor and County entered into an Agreement on May 15, 2020, in which the Vendor agreed to provide movie and equipment services to the County for eight (8) movie nights to be held at The Endowment Center Memorial Park – San Carlos Park 107 Sunflower Rd. Edinburg TX, or J.R. “Milo” Ponce Memorial Park 3516 E. 2812 FM. Edinburg TX;

WHEREAS, County chose to cancel all the originally agreed upon dates in response to the COVID-19 pandemic and then Hurricane Hanna, as authorized by the terms of the Agreement,

WHEREAS, the term of the Agreement was for a period of four (4) month(s), commencing on June 1, 2020 and expiring on September 30, 2020; and

WHEREAS, the Parties wish to extend the Agreement for an additional three (3) month(s);

WHEREAS, the Parties do not wish to specifically designate eight (8) dates to hold movie nights due to the ever changing circumstances during this pandemic;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Vendor and County hereby agree that said Agreement is amended as follows:

1. The Agreement is hereby amended so that, the Term clause, paragraph number 3, is deleted and replaced with the following language:

Term. This Contract shall be for a period of **three (3) months**, commencing on **October 1, 2020** and expiring on **December 31, 2020**, and during the Contract period, eight (8) movie nights will be held, at one designated location per movie night, either at The Endowment Center Memorial park or the J.R. “Milo” Ponce Memorial Park, on Fridays, specific dates designated at the County’s discretion, and any dates canceled pursuant to paragraph 3(a.) may be rescheduled at the sole discretion of the County under the same rates, terms and conditions unless this Contract is terminated pursuant to the provisions herein, whichever occurs first.

2. Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect.


