**ORDER**

**AN ORDER OF THE COMMISSIONERS COURT OF HIDALGO COUNTY TEXAS, APPROVING AMENDMENT NO. 1 TO THE ADVANCE FUNDING AGREEMENT FOR AN OFF-SYSTEM ROADWAY PROJECT WITH THE STATE OF TEXAS ACTING BY AND THROUGH THE TEXAS DEPARTMENT OF TRANSPORTATION TO WIDEN AND RECONSTRUCT NOLANA LOOP TO A FOUR LANE DIVIDED URBAN ROADWAY FROM FM 1426 TO FM 88; MAKING THIS ORDER A PART OF THE AGREEMENT.**

WHEREAS, Hidalgo County has agreed to enter into that certain Advance Funding Agreement- Amendment No. 1 with Texas Department of Transportation for the widening and reconstruction of Nolana Loop from FM 1426 to FM 88 which would benefit the residents of Hidalgo County (the "Advance Funding Agreement-Amendment No. 1);

NOW THEREFORE, BE IT ORDERED, that the Hidalgo County Commissioners Court hereby approves the Advance Funding Agreement- Amendment No. 1 for the widening and reconstruction of Nolana Loop to a four lane divided urban roadway from FM 1426 to FM 88 and that this Order is made part of the Advance Funding Agreement- Amendment No. 1 by attaching it to the Agreement as Attachment A-1.


FURTHER ORDERED, that Richard F. Cortez, County Judge of Hidalgo County, is authorized to execute the Advance Funding Agreement-Amendment No. 1 for CSJ 0921-02-169.
