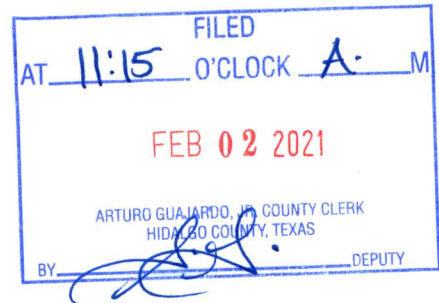

**WHEREAS**, the parties desire to amend the Contract as hereinafter provided.

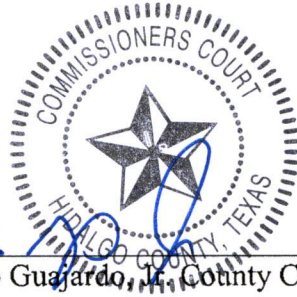
