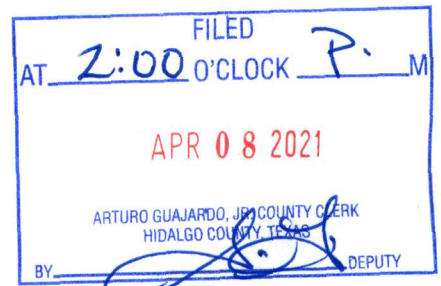

BETWEEN HIDALGO COUNTY AND MATT'S BUILDING MATERIAL,
C-20-211-07-21**

This AMENDMENT to the Contract C-20-211-07-21 (the "Agreement") is entered into and effective the 23rd of March, 2021, by and between Matt's Building Material, Inc. ("County") and **HIDALGO COUNTY, TEXAS** ("Company" or "Seller"), is made between the County and the Company, (the "Amendment"), as follows:

WHEREAS, County and Company executed the Agreement, between County and Company, on July 21, 2020, in which the Company agreed to provide County with Construction Building Materials & Related Supplies."

WHEREAS, the County and Company have agreed to modify the Agreement to exclude any and all Plywood and Lumber materials.

WHEREAS, County and Company have agreed that any and all Plywood and Lumber materials will be excluded for the final Six (6) month extension.

WHEREAS, the parties desire to amend the Agreement as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Agreement.

1. Replace "Exhibit B" with updated "Exhibit B", attached hereto for all purposes that reflects the lists of goods to be made a part of C-20-211-07-21, and which specifically excludes plywood and lumber materials from the agreement for the remainder of the final six (6) month extension.

Except as modified herein, all terms and conditions of the Agreement, as amended by this Amendment, remain in full force and effect and County and Company ratify and confirm the terms and provisions of the Agreement, as amended by this Amendment herein.


