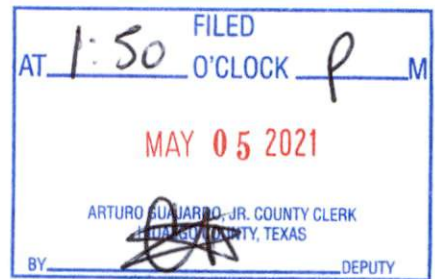

**AMENDMENT No. 1
BETWEEN HIDALGO COUNTY AND MID VALLEY CEMETERY INC., D/B/A VAL
VERDE MEMORIAL GARDENS,
C-19-060-03-26**

This AMENDMENT to the Contract C-19-060-03-26 (the “Agreement”) is entered into and effective the 23rd of March, 2021, by and between Mid Valley Cemetery, Inc., d/b/a Val Verde Memorial Gardens, (“Company” or “Seller”) and **HIDALGO COUNTY, TEXAS** (“County”), is made between the County and the Company, (the “Amendment”), as follows:

WHEREAS, County and Company executed the Agreement, between County and Company, on March 26th, 2019, in which the Company agreed to provide County with “Turnkey Burial Services (Including Cemetery Plots) for Unidentified Pauper Remains”, and referenced a term of March 26, 2019, and ending on January 25, 2021.

WHEREAS, the County’s initial Request for Sealed Quotes (RFSQ) stated that the “term of the contract is for a period of two (2) years with the County’s option to renew for an additional one (1) year under the same rates, terms and conditions.

WHEREAS, due to the discrepancy, the County and Company have agreed to modify the Agreement to clarify Paragraph # 3, to state the correct term as provided below.

WHEREAS, the parties desire to amend the Agreement as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Agreement.

1. Number 3 of the initial Agreement is removed and replaced with the following:

“3. This Contract shall be for a period beginning March 26, 2019, and ending March 25, 2021, and may be extended at the sole discretion of the County of an additional one (1) year term, unless this Contract is terminated pursuant to the provisions herein, whichever occurs first. County also reserves the right to continue this quote for an additional sixty (60) day grace period at the end of the contract term, under the same rates, terms, and conditions.”

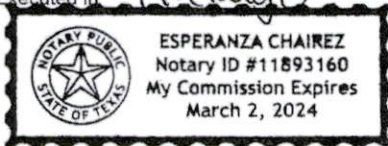
