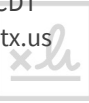

**FIRST AMENDMENT TO SERVICE CONTRACT
(C-20-059-08-04)**

This AMENDMENT to the Service Contract (“**Contract**”) is made on this the 09 day of August, 2022, by and between the **County of Hidalgo, Texas** (the “**County**”) and **MLG Protection Services** (the “**Company**”).

WHEREAS, on or about August 04, 2020, the County and Company entered into a Contract for "SECURITY GUARD SERVICES" (on an as needed basis); and

WHEREAS, it has become necessary to extend and modify the contract rates;

Level III (Armed) Guard \$14.68

3. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. County and Company ratify and confirm the terms and provisions of the CONTRACT as amended herein.
