**SECOND AMENDMENT TO INTERLOCAL AGREEMENT  
BETWEEN STARR COUNTY AND THE COUNTY OF HIDALGO  
(C-18-191-07-17: HOUSING OF PRISONERS IN STARR COUNTY DETENTION  
FACILITY)**

This Second Amendment to the Interlocal Agreement (the “Agreement”) is made and entered on this 9<sup>th</sup> day of August, 2022, by and between Hidalgo County, Texas (the “County”) by and through the Hidalgo County Sheriff’s Office (“HCSO”) and STARR County, Texas, a political subdivision of the state of Texas (“STARR”).

WHEREAS, the County and STARR entered into an Interlocal Agreement dated July 18, 2018, wherein STARR agreed to house prisoners for HIDALGO (both males and females) in the Starr County Detention Facility in compliance with jail regulations as promulgated by the Texas Commission on Jail Standards;

WHEREAS, the Agreement was for a one year term with automatic one year renewals and both parties have agreed to restate and continue to carry out the services as outlined in the Agreement;

WHEREAS, on August 6, 2019, the County, by and through HCSO and STARR agreed to amend the contract to increase the daily inmate housing fee by \$6.00 to a daily fee of \$60.00 per inmate;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, STARR, the County, by and through HCSO, hereby agree to the following amendment to the Agreement:

1. Numbered paragraph 2 shall be deleted in its entirety and the following shall be substituted in lieu thereof:

“HIDALGO shall pay STARR a daily prisoner-housing fee of SIXTY-TWO DOLLARS AND NO CENTS (\$62.00) per prisoner a day. The day the prisoner is "booked in" will be counted and charged. The day the prisoner is "booked out" will not be counted or charged. STARR will mail HIDALGO a monthly, itemized invoice showing the actual number of HIDALGO prisoner days in that month and the daily HIDALGO prisoner count. HIDALGO will remit the full amount of the invoice to the Starr County Auditor's Office within thirty (30) days of receipt thereof.”

Except as modified herein, all terms and conditions of the **Agreement** remain in full force and effect. **STARR**, the **County**, by and through **HCSO** ratify and confirm the terms and provisions of the **Agreement** as amended herein.
