**FIRST AMENDMENT TO SERVICE CONTRACT
(C-21-035B-11-30)**

This **AMENDMENT** to the service contract for “**DNA Testing Lab Services**” for **Hidalgo County** in connection to original contract **C-21-035B-11-30 (the “Contract”)**, dated November 30th, 2021, by and between **HIDALGO COUNTY, TEXAS** (“**County**”) and **BODE Technology** (“**Company**”) is entered into between the parties effective this **20th of September 2022**.

WHEREAS, Company and County (collectively the “**Parties**”) entered into a Contract dated **November 30th, 2022**, in which Company agreed to provide “**DNA Testing Lab Services**” for **Hidalgo County**;

WHEREAS, Section 22 titled Entire Agreement allows for the Contract to be modified or amended “by agreement in writing executed by both parties hereto, and not otherwise”;

WHEREAS, it has become necessary to modify the pricing structure of the contract;

WHEREAS, the County also wishes to exercise its option for annual renewal of the contract and;

WHEREAS, the Parties wish to modify the Contract as hereinafter provided.

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following modification or amendment to the Contract:
