If service location is obstructed (I.E. vehicle, closed gates, etc), loaded above top flange, or too heavy for pickup, a \$110 dry run fee will be assessed.
- A \$3.00 Per day rental fee per roll-off will be assessed starting on the delivery date and ending upon removal.
- Containers called in for service that are empty upon driver arrival, will be assessed the full service fee depending on container size as per price list above.
