**THIS SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, hereinafter called the “**Owner**”, and **L&G Consulting Engineers, Inc., d/b/a L&G ENGINEERING**, professional engineers of Mercedes, Texas, hereinafter called the “**Engineer**”.

**WITNESSETH**

**WHEREAS**, the **Owner** and the **Engineer** executed the Main Contract Agreement on the 16th day of October, 2012, concerning professional engineering services for the “Tom Gill/Liberty Road (from US Expressway 83 to FM 2221)” project for Hidalgo County Precinct No. 3; and;

**WHEREAS**, Article 3 of the Agreement, Period of Service, established this agreement shall terminate on the earlier of October 16, 2020 or upon completion of the projects, unless extended by written supplemental agreement; and,

**WHEREAS**, it has become necessary to amend the Agreement for Professional Services, to extend the termination date.

**A. AGREEMENT**

**NOW, THEREFORE**, premises considered, the **Owner** and the **Engineer** agree that said **Agreement** is amended as follows:

1. Article 3 of the Agreement, Section 3.1 Termination Date, is revised to extend the termination date of October 16, 2022 to **October 16, 2024** for a total of an additional two (2) years in order to complete the scope of services for this project as outlined in the attached Exhibit “C” Work Schedule.

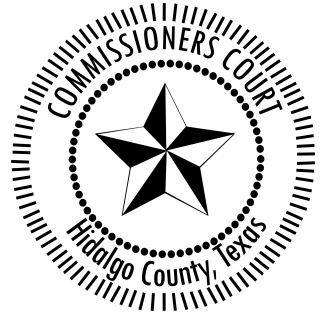
