**FIRST AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT &
BUSINESS ASSOCIATE AGREEMENT BETWEEN THE COUNTY OF HIDALGO
AND EDINBURG CONSOLIDATED INDEPENDENT SCHOOL DISTRICT**

This **FIRST AMENDMENT** to the **INTERLOCAL COOPERATION AGREEMENT** and **INCORPORATED BUSINESS ASSOCIATE AGREEMENT** (“**AMENDMENT**”) is made this 17th day of **January, 2023** by and between **HIDALGO COUNTY, TEXAS** (the “**COUNTY**”) and **EDINBURG CONSOLIDATED INDEPENDENT SCHOOL DISTRICT** (the “**DISTRICT**”).

WHEREAS, County and District entered into an Interlocal Cooperation Agreement and Incorporated Business Associate Agreement on January 26, 2021 (the “**AGREEMENT**”) in which the Parties agreed to assist one another to improve local bioterrorism preparedness and response to outbreaks on infectious disease and other public health threats and emergencies as part County being a recipient of a Public Health Emergency Preparedness grant from the Department of State Health Services;

WHEREAS, the current Agreement calls for an initial term of two (2) years commencing on January 26, 2021, and Parties may agree to another two (2) year extension by a written amendment signed by both Parties,

WHEREAS, Interlocal Agreements regarding this same subject were entered into with other entities which indicated an initial term of five (5) years and the option for Parties to extend for an additional five (5) year term by written amendment.

WHEREAS, the parties have now determined to amend the Agreement to reflect the same term and potential extension of term as indicated in other similarly entered agreements as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions of this First Amendment to the Interlocal Agreement, both parties hereby agree to the following amendment to the Agreement.

1. To extend the initial term and renewal term of the Agreement by replacing **No. 12 Term** section with the following:

12. Term. This agreement becomes effective when executed by both parties. Either party may cancel it by giving thirty (30) days' notice to the other party; otherwise it remains in effect for five (5) years from the commencement date (January 26, 2021-January 25, 2026), and may be renewed for a period of another five (5) years by a written amendment signed by both parties. Any notice or communication required or permitted shall be given in writing.

2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect. County and District ratify and confirm the terms and provisions of the Agreement as amended.




