**SUPPLEMENTAL AGREEMENT NO. 3  
TO AGREEMENT FOR PROFESSIONAL SERVICES  
C-15-110-03-31**

**THIS SUPPLEMENTAL AGREEMENT** is made pursuant to the terms and conditions of Article 8 of the Agreement made by and between **HIDALGO COUNTY**, hereinafter called the "**Owner**", and **L&G Consulting Engineers Inc, d/b/a L&G Engineering**, professional engineers of Mercedes, Texas, hereinafter called the "**Engineer**".

**WITNESSETH**

**WHEREAS**, the **Owner** and the **Engineer** executed the Main Contract Agreement on the 31<sup>st</sup> day of March, 2015 concerning professional engineering services for the "FM 1925 (from 1,500ft. West of 10<sup>th</sup> Street to McColl Road) project for Hidalgo County Precinct No. 4; and,

**WHEREAS**, Article 3 of the Agreement, Period of Service, establishes this agreement shall terminate on the earlier of March 29, 2023 or upon completion of the projects, unless extended by written supplemental agreement; and,

**WHEREAS**, it has become necessary to amend the Agreement for Professional Services, to extend the termination date.

**A. AGREEMENT**

**NOW, THEREFORE**, premises considered, the **Owner** and the **Engineer** agree that said **Agreement** is amended as follows:

1. Article 3 of the Agreement, Section 3.1 Termination Date, is revised to extend the termination date of March 29, 2023 to **March 29, 2027** for a total of an additional four (4) years in order to complete the scope of services for this project as outlined in Exhibit C – Work Schedule.

All other provisions are unchanged and remain in full force and effect.





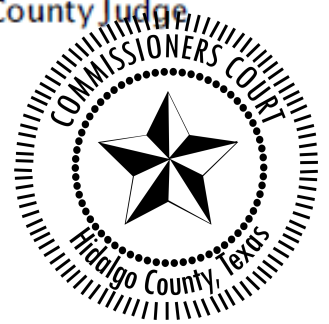
