ORDER APPROVING THE EXECUTION OF THE ADVANCE FUNDING AGREEMENT (AFA) WITH AUTHORITY FOR THE COUNTY JUDGE TO SIGN THE AGREEMENT WITH TXDOT FOR THE HIGHWAY SAFETY IMPROVEMENT PROGRAM OFF-SYSTEM PROJECT FOR THE INSTALLATION OF OVERHEAD FLASHING BEACONS ON THE INTERSECTION OF CESAR CHAVEZ ROAD AND RIDGE ROAD, MILE 4 W ROAD AND MILE 16 ROAD, MILE 6 W ROAD AND MILE 12 ROAD, RAMSEYER ROAD AND KENYON ROAD, TEXAN ROAD AND 4 MILE LINE ROAD, AND TEXAN ROAD AND 8 MILE LINE ROAD.

WHEREAS, the County of Hidalgo and the Texas Department of Transportation (TXDOT) have identified the need for the installation of overhead flashing beacons on the intersection of Cesar Chavez Road and Ridge Road, Mile 4 W Road and Mile 16 Road, Mile 6 W Road and Mile 12 Road, Ramseyer Road and Kenyon Road, Texan Road and 4 Mile Line Road, and Texan Road and Mile 8 Line Road; and,

WHEREAS, the governing bodies of TXDOT and the County of Hidalgo (the "Parties") have identified certain common, legitimate public purpose in entering into this agreement; and,

WHEREAS, the Parties have each met in legally convened open meetings and authorized their respective representatives to enter into this agreement.

NOW, THEREFORE, BE IT ORDERED, the County Commissioners Court approves the execution of the Advance Funding Agreement for the installation of overhead flashing beacons on the intersection of Cesar Chavez Road and Ridge Road (CCSJ#0921-02-484 / CSJ#0921-02-484), Mile 4 W Road and Mile 16 Road (CCSJ#0921-02-484 / CSJ#0921-02-487), Mile 6 W Road and Mile 12 Road (CCSJ#0921-02-484 / CSJ#0921-02-488), Ramseyer Road and Kenyon Road (CCSJ#0921-02-484 / CSJ#0921-02-490), Texan Road and 4 Mile Line Road (CCSJ#0921-02-484 / CSJ#0921-02-486), and Texan Road and Mile 8 Line Road (CCSJ#0921-02-484 / CSJ#0921-02-485) and authorizes the County Judge to sign said agreement with TXDOT.
