**2nd AMENDMENT TO SERVICE CONTRACT
 C-22-0402-09-20**

This **AMENDMENT** to the service contract for “**Fire Alarm & Security Monitoring Services**” for **Hidalgo County** in connection to original contract **C-22-0402-09-20**, dated September 20, 2022, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **Triple R Fire & Safety, LLC** (“Company”) is entered into between the parties effective this **7th** day of **March 2023**.

WHEREAS, Company and County entered into a Contract dated **September 20, 2022**, in which Company agreed to provide certain services for the purpose of “**Fire Alarm & Security Monitoring Services**” for **Hidalgo County** (the “Contract”);

WHEREAS, Section j, titled “Entire Agreement” allows for C-22-0402-09-20 to be modified or amended “only by an agreement in writing executed by County and Company, and not otherwise”;

WHEREAS, on or about January 3, 2023, Company and County entered into a First Amendment to the Service Contract to reflect revised pricing due to upgrading all fire panels to cellular communication and additional service locations.

WHEREAS, the parties now desire to further amend the Contract to include additional buildings in “Exhibit B – Company’s Response”;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. Parties wish to clarify the agreement of the Parties in Amendment Number 1 by indicating that the Contract is amended by Parties to revise pricing for “fire monitoring service” for all buildings listed in “Exhibit B – Company’s Response” and as amended to \$39.99 per service location.
2. In addition to the service locations indicated in “Exhibit B” of the Initial Service contract and Amendment Number 1, “Exhibit B” to the Contract under the heading “Company’s Response” shall be amended to include the following additional service location(s);
